VISAS

The foreign citizen who wants to travel to Colombia and requires a visa for entry, must initially pay for the visa study. You can **VERIFY** If you need a Visa and then register your visa application on the following website https://www.cancilleria.gov.co/tramites_servicios/visa Once you have your **application number**, you must pay for the visa study.

You can do the payment of the visa study with your Credit Card easily and quickly through the following platform (you only need your credit card and the application number):
